We conduct sports and outdoor recreational activities for children and adults for the purposes of training as well as participation in events and / or tournaments (collectively referred herein as “Activities”). ### 1. OVERVIEW

### **5. USE OF COOKIES**

5.1 Our Websites uses cookies to store and track information about you when you access our Websites. 5.3 Such information may include as follows: -

(a) Browser and device data, such as your IP address, Internet browser type and membership account details, but only to the extent that CG may identify you from such information; and

(b) Usage data on your preferred Sites, language settings, pages viewed, web-links clicked and pages that have brought you to our Website.

5.4 Disabling cookies may prevent you from entering certain part(s) of our Websites.

7.1 For the avoidance of doubt, the aforementioned Activities shall include those listed on our Websites i.e. Rugby, Touch, Netball, Cycling, Jungle Runs, Events, of which covers recreational and competitive training, matches, leagues, tournaments as well as multi-sport Pit Parties and holiday camps hosted by CG and / or other clubs / schools. Included within our Activities but not via the website is the collection of Personal Data from individuals and entities hiring CG's sports facilities.

## **8. PURPOSE FOR THE COLLECTION, USE AND DISCLOSURE OF YOUR PERSONAL DATA**

8.1 We use your Personal Data for the purpose of facilitating business relationships in compliance with financial and legal regulatory obligations.

(A) **Contractual purposes for legitimate business interests**
